

## **Wildhorse Market Rules**

Vendors must hold all required permits, licenses, and insurance necessary for their business.

Vendors are responsible for their own sales taxes. Wildhorse Gardens & Market is NOT responsible for collection of sales taxes.

Wildhorse Gardens & Market reserves the right to reject a vendor's request to participate in the Market.

The Market is a "G" rated environment. No questionable merchandise may be sold or displayed at the market. Foul language is not permitted. No alcoholic beverages are permitted. No smoking is permitted at Mustang Town Center, which includes the community garden and farmers market.

Vendors must comply with all applicable health regulations at all times. No live animals are allowed at the market.

Spaces for vendors may be assigned at the discretion of the Market Manager. Vendors must pay their market fee before they can occupy a vendor space. The minimum vendor fee allows for 2 – 8 ft tables. Additional tables may be subject to additional fees.

Only Oklahoma grown produce may be sold at the Market.

Vendors must represent their products in an honest and non-deceptive manner at all times.

All vendors must have a sign prominently displayed with their name or the name of their business displayed in their space.

All vendors must keep their space safe, clean and hazard free. At the end of the market, each vendor must leave their selling area clean and free of trash.

Market spaces should be attended at all times. Vendor assumes responsibility for any losses of produce, product or money from their vendor space.

Vendors must conduct themselves in a courteous manner to customers, other vendors and market volunteers.

No loud noise, music or aggressive promotion is allowed.

Vendors are asked to set up a minimum of 15 minutes prior to market open times. No vehicles are allowed in or out of the market area during the time the market is open.

Vendors must supply their own tables, tents and other market equipment. Tents and other equipment must be well secured for safety reasons.

Suggestions for improvements are welcome. Complaints or problems will be resolved through the Market Manager. Rules and fees are subject to change.
